# Catalina 36, Fleet 9

## AGREEMENT AND RELEASE FROM LIABILITY

I have voluntarily applied for membership and to participate in the activities of Catalina 36, Fleet 9, ("Fleet 9" herein), which include, among other things, sailing in both inland waters and the open ocean.

**I AM FULLY AWARE THAT SAILING IS A HAZARDOUS ACTIVITY. I AM VOLUNTARILY PARTICIPATING IN THE ACTIVITIES OF FLEET 9 WITH KNOWLEDGE OF THE DANGERS INVOLVED AND AGREE TO ACCEPT ANY AND ALL RISKS OF DAMAGE TO MY VESSEL AND/OR INJURY OR DEATH TO MYSELF, MY CREW AND GUESTS. I AM FURTHER AWARE AND AGREE THAT I AM IN SOLE COMMAND OF AND RESPONSIBLE FOR MY VESSEL AND ITS OCCUPANTS AT ALL TIMES WHILE PARTICIPATING IN THE ACTIVITIES OF FLEET 9, AND THAT ANY DECISION TO PARTICIPATE IN A SPECIFIC ACTIVITY OR EVENT IS MINE ALONE.**

In consideration for being permitted to participate in these activities, I hereby release Fleet 9, its officers, directors and members, from all actions, claims, levies, or demands that I, my assignees, heirs, guardians and legal representatives now have or may have in the future for injury or damage resulting from participation in any Fleet 9 activity, however caused.

I agree to indemnify, defend, and hold harmless Fleet 9, its officers, directors, agents, and members, of any liability of any nature whatsoever for accident, injury or damage to my crew, my guests, and/or any vessel owned by me or under my command, however caused, while engaging in activities related to or connected with Fleet 9. I acknowledge that any decision regarding my vessel or any under my command, and its use, shall be solely my own. I will likewise indemnify, defend and hold harmless Fleet 9, its officers, directors, agents, and members, of all liability for any accident, injury or damage allegedly caused by me or my vessel to other persons or vessels.

**I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND IT CONTENTS. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT BETWEEN ME AND FLEET 9, AND EACH OF ITS MEMBERS. I SIGN THIS RELEASE OF MY OWN FREE WILL.**

I further understand that the term of this agreement is indefinite and shall apply to any situation in which I participate in an activity of the Fleet 9.

This document shall be executed by any person who owns or commands a vessel which participates in Catalina 36, Fleet 9 activities.
